CORPORATE GOVERNANCE POLICY

1. PREAMBLE

As an organization, we endeavor to use the power of business to solve social and environmental problems in an ethical and transparent manner. We set rigorous standards of social and environmental performance, accountability, and transparency. We also continuously evaluate how our practices impact our employees, our community, the environment, and our customers.

Almost all of our clients/borrowers are businesses that solve social or environmental problems. We hold ourselves, as well as our portfolio companies, to high standards of governance, transparency and ethics.

We believe in working for the benefit of all stakeholders.

The Company ensures good governance through the implementation of effective policies and procedures, which is mandated and regularly reviewed by the Board or the Committees of the members of the Board.

The objective of the policy is to ensure compliance with legal requirements and set standards for Corporate Governance so that concerned officers act in accordance with the highest standards of governance while working for and on behalf of the Company. All the concerned are expected to read and understand these guidelines to uphold these standards in day-to-day activities and comply with all applicable policies and procedures.

The purpose of this policy is to frame internal guidelines on Corporate Governance. This policy shall lay down the detailed procedures for the implementation of the said guidelines in order to comply with the directions issued by the Reserve Bank of India in this regard.

2. CONTEXT AND PURPOSE

This Policy on Corporate Governance ("Policy") draws reference to the Master Direction- Reserve Bank of India (Non-Banking Financial Company – Scale Based Regulation) Directions, 2023 ("Directions") issued by the Reserve Bank of India ("RBI") including any amendment, revision in the directions made thereunder and issuance of any guidelines, notification, circular by the RBI in this regard from time to time, SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI LODR 2015"), as applicable and all applicable laws including Companies Act, 2013 and relevant Secretarial Standards.

This Policy is to be read in conjunction with Applicable Laws; accordingly, this Policy enhances the provisions of Applicable Laws.

3. DEFINITIONS

In this Policy, unless the context otherwise requires:

- a) **"Applicable Laws"** means the Companies Act, 2013 and the rules made thereunder, Master Circular - Non-Banking Financial Companies – Corporate Governance (Reserve Bank) Directions, 2015, RBI Directions as stated above, Listing Agreement for Debt Securities, applicable Secretarial Standards issued by The Institute of Company Secretaries of India from time to time and includes any other statute, law, standards, regulations or other governmental instruction relating to Corporate Governance Guidelines;
- b) **"SEBI LODR"** means the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, including any amendments, circulars, notifications, or guidelines issued thereunder.
- c) **"Listed Entity"** means a company whose securities are listed on a recognized stock exchange in accordance with SEBI Act and SEBI LODR 2015.
- d) **"Audit Committee"** means the Audit Committee formed under Section 177 of the Companies Act, 2013, as well as such Committee of the Board formed for the purpose of adherence to this Policy in accordance with the Directions;
- e) **"Board of Directors" or "Board"** means the collective body of the directors of the Company;

- f) **“Chief Financial Officer”** means chief financial officer as defined in Section 2(18) of Companies Act, 2013 or any modification or re-enactment made thereunder for the time being in force;
- g) **“Company”** means Caspian Impact Investments Private Limited;
- h) **“Committees”** means Committees of Board of Directors constituted by virtue of Directions or other Applicable Laws;
- i) **“Companies Act, 2013”** includes any statutory modification(s), enactment(s) or re-enactment(s) thereof for the time being in force;
- j) **“Company Secretary”** means a Company Secretary as defined in Section 2(24) of Companies Act, 2013 or any modification or re-enactment made thereunder for the time being in force;
- k) **“Corporate Governance”** means a set of relationships between the Company’s management, its Board, its shareholders and other stakeholders which provide the structure through which the objectives of the Company are set, and the means of attaining those objectives and monitoring performance. It helps to define the way authority is allocated and the way corporate decisions are arrived at and executed;
- l) **“Directions”** means Master Circular - Non-Banking Financial Companies - Corporate Governance (Reserve Bank) Directions, 2015 and Master Direction - Reserve Bank of India (Non-Banking Financial Company - Scale Based Regulation) Directions, 2023 shall include any amendment thereto;
- m) **“Director”** means a director appointed to the Board of the Company;
- n) **“Independent Director”** means an independent director defined in Section 2(47) of Companies Act, 2013 or any modification or re-enactment made thereunder for the time being in force;
- o) **“Nomination Committee”** means the Nomination & Remuneration Committee (“NRC”) formed under Section 178 of the Companies Act, 2013, as well as such Committee of the Board formed for the purpose of adherence to this Policy in accordance with the Directions;
- p) **“Risk management”** means the process established to ensure that all material risks and associated risk concentrations are identified, measured, limited, controlled, mitigated and reported on a timely and comprehensive basis;

q) **“Risk Management Committee”** means the Risk Committee or any such Committee of the Board formed for the purpose of adherence to this Policy in accordance with the Directions;

r) **“Senior Management”** shall mean personnel of the Company who are members of its core management team excluding the Board of Directors. This would also include all members of management one level below the executive directors including all functional heads and Key Managerial Personnel (KMPs) as defined under the Companies Act, 2013.

4. **GUIDELINES ON CORPORATE GOVERNANCE**

The Company has framed the following internal guidelines on Corporate Governance.

5. **BOARD OF DIRECTORS**

a) The Board shall be responsible for exercising its business judgments to act in what it reasonably believes to be in the best interests of the Company and its shareholders. The Board of Directors along with its constituted Committees shall provide direction and guidance for the Company and shall further supervise and review the performance of the Company.

b) The Board shall ensure compliance with the Corporate Governance requirements prescribed under Regulations 17 to 27 and Schedule II of SEBI LODR 2015 (as applicable to the Company based on the nature of its listed securities).

c) The roles and responsibilities of the Board shall also include those specified in Part A of Schedule II of SEBI LODR, 2015, such as:

- Laying down ethical standards and ensuring proper implementation of Code of Conduct;
- Reviewing and guiding corporate strategy, risk policy, and annual budgets;

- Monitoring effectiveness of governance practices and making changes as needed;
 - Ensuring the integrity of accounting and financial reporting systems.
- d) As the Directors occupy fiduciary position, they shall attend and actively participate in Board and its Committee meetings thereof, on which they serve, and shall properly discharge their responsibilities.
- e) The Board shall be responsible for overall compliance with the Corporate Governance of the Company and oversee the business affairs including responsibility for the Company's business strategy and financial soundness, key personnel decisions, internal organisation and governance structure and practices, Risk Management and compliance obligations and in doing so the Board must act honestly, in good faith and in the best interests of the Company.
- f) The Board should ensure that the Company's organisational structure enables the Board and Senior Management to carry out their responsibilities and facilitates effective decision-making and good governance. This includes clearly laying out the key responsibilities and authorities of the Board itself, of Senior Management and of those responsible for the control functions.
- g) The Board should actively engage in the major matters of the Company and keep up with material changes in the Company's business and the external environment as well as act in a timely manner to protect the long-term interests of the Company.
- h) The Board should ensure that transactions with related parties are reviewed to assess risk and are subject to appropriate resolutions/approval, as required under various applicable laws and that corporate or business resources of the Company are not misappropriated or misapplied.
- i) The Board should review this Policy periodically so that it remains appropriate in the light of material changes in regulatory requirement with respect to the Company's size, complexity, geographic reach, business strategy, market and best governance practices.

6. CORPORATE CULTURE AND VALUES

In order to promote sound corporate culture and values, the Board should ensure the following:

- a) setting and adhering to corporate values for itself, Senior Management and other employees that create expectations that all business should be conducted in a legal and ethical manner;
- b) promoting risk awareness within a strong risk culture, conveying the Board's expectation that it does not support excessive risk-taking and that all employees are responsible for helping ensure that the Company operates within the agreed risk appetite and risk limits;
- c) ensuring that appropriate steps are taken to communicate throughout the Company the corporate values, professional standards or Code of Conduct it sets, together with supporting policies;
- d) employees should be encouraged and able to communicate, confidentially and with out the risk of victimization, legitimate concerns about illegal, unethical or questionable practices. This will be facilitated through the existing Whistle Blower Policy including any modification(s) or revision(s) thereto.

7. OVERSIGHT OF SENIOR MANAGEMENT

The Board should delegate proper authority to the Executive Director who are responsible for the day-to-day affairs of the Company to oversee the Senior Management who should hold members of Senior Management accountable for their actions and enumerate the consequences if those actions are not aligned with the Board's performance expectations. This includes adhering to the Company's values, risk appetite and risk culture, regardless of financial gain or loss to the Company. In doing so, the Board should through the Executive Director:

- a) monitor that Senior Management's actions are consistent with the strategies and policies approved by the Board;
- b) meet regularly with Senior Management;
- c) Interrogate and critically review reply and information provided by Senior Management;

- d) ensure that Senior Management's knowledge and expertise remain appropriate given the nature of the business and the Company's risk profile;
- e) ensure that appropriate succession plans are in place for Senior Management positions.
- f) To inculcate the values of governance, transparency and ethics into every new employee that joins us, and to constantly strive for improvement, and to align with best practice in our engagement and interaction with clients, employees and our community.
- g) Disclosures of shareholding and other material interests of senior management shall be made to the Board as per Regulation 26(5) of SEBI LODR, 2015.

8. SIZE OF THE BOARD

- a) The Board's strength shall be as per the limits specified in the Companies Act, 2013 and the Articles of Association of the Company
- b) The Company shall maintain the Board size in line with Regulation 17(1) of SEBI LODR, 2015, ensuring at least one-woman director and such number of independent directors as mandated based on the listed status of the entity.

9. BOARD COMPOSITION

- a) The Board shall have an optimum combination of Executive, Non-executive and Independent Directors in line with the requirements of the provisions of the Companies Act, 2013 and other Applicable Laws and the Articles of Association of the Company.
- b) The composition shall adhere to Regulations 17(1) to 17(1C) of SEBI LODR, 2015, which specify the requirements for Independent Directors, Woman Director, Chairperson, and separation of Chairperson & MD roles, where applicable.

10. BOARD MEETINGS AND QUORUM

- a) The Board Meetings of the Company shall be held as per the requirements prescribed under the Companies Act, 2013, other Applicable

Laws, Articles of Association and as decided by the Board of Directors. The meetings of the Board shall generally be held at the Company's registered office unless otherwise decided by the Board of Directors. The dates of the meetings shall be fixed well in advance. The quorum shall be as per the requirements of the Companies Act, 2013, other Applicable Laws and Articles of Association of the Company.

- b) The Company shall ensure compliance with the provisions of Regulation 17(2) of SEBI LODR, 2015, regarding the frequency and quorum of Board Meetings.
- c) Important/Urgent decisions of the Board may also be taken through Circular Resolution in compliance with the provisions of the Companies Act, 2013.

11. INFORMATION TO BE PLACED BEFORE BOARD AND ITS COMMITTEES

- a) To enable the Board members to discharge their responsibilities effectively and take informed decisions, detailed agenda papers, with explanations on each item, shall be sent to each Director well in advance of the Board and its Committee meetings as per Companies Act, 2013, other Applicable Laws and Articles of Association of the Company. All the items on the agenda shall be discussed in detail, during the Board and its Committee meetings. The Board members shall have complete access to any information, within the Company. At the meetings, the Board members shall be provided with all the relevant information on important matters affecting the working of the Company as well as the related details that required deliberation by the members of the Board.
- b) As per Schedule II, Part A of SEBI LODR, the following items shall be placed before the Board:
- Annual operating plans and budgets;
 - Quarterly results;
 - Minutes of Committee meetings;
 - Material default in financial obligations;
 - Show cause notices or legal actions;

- Any significant development that may affect business.

12. AGENDA FOR THE MEETING

The agenda for the Board and its Committee meetings shall be sent to the Board members and the Committee members respectively within a reasonable period of time prior to the Meeting as per Companies Act, 2013 and other Applicable Laws. Each Board member and Committee member as the case may be is free to suggest inclusion of items in the agenda.

With the permission of the Chair, each Board member and Committee member as the case may be is free to raise any matter(s) that is/are not on the agenda of the Board and the Committee Meeting respectively and any other matter can be placed for discussion unless there are any regulatory restrictions. However, with reference to any sensitive matter on the agenda, relevant information can be made available only at the time of the Board Meeting or the Committee meeting as the case may be.

13. ATTENDANCE AT BOARD MEETINGS

The Directors shall strive to attend all meetings of the Board and its Committees where they are members. In case a Director is unable to attend specific Board Meeting or its Committees where they are members, he or she shall obtain leave of absence from the Board or the Committee as the case may be.

14. MINUTES

The minutes of all meetings of the Board and the Committees shall be circulated to the Board and the Committee respectively and shall be noted in the consequent Board Meeting and Committee meeting respectively as per Companies Act, 2013 and other Applicable Laws. Minutes of meetings of Committees of Board shall also be placed before the Board.

15. BOARD COMMITTEES

- a) In order to focus on the critical functions of the Company, the Board may constitute such Committees as and when required to ensure smooth functioning of the Company. The Board shall have the following Committees mandatorily:

- Audit Committee;
 - Nomination and Remuneration Committee;
 - Risk Management Committee; and
 - Corporate Social Responsibility (CSR) Committee
- b) The constitution and functioning of Board Committees shall comply with Regulations 18 to 21 of SEBI LODR, 2015, where applicable. The following committees are mandatory for listed companies:
- Stakeholders Relationship Committee (Regulation 20)
 - Audit Committee (Regulation 18)
 - Nomination and Remuneration Committee (Regulation 19)
 - Risk Management Committee (Regulation 21)
- c) The terms of reference of the above-mentioned Committees shall be determined by the Board from time to time as per Companies Act, 2013 and other Applicable Laws.

16. DETAILS OF THE VARIOUS BOARD COMMITTEES

- a) The Terms of Reference, Composition, Meetings, Quorum, Minutes and Role of the Audit Committee, Nomination and Remuneration Committee, Corporate Social Responsibility Committee, Risk Management Committee, and Stakeholder Relationship Committee shall be as decided by the Board of Directors from time to time subject to provisions contained in the Direction, relevant provisions of the Companies Act, 2013 and other Applicable Laws applicable to the Company.
- b) The Audit Committee must ensure that an Information System Audit of the internal systems and processes is conducted at least once in two years to assess operational risks faced by the Company.
- c) The Audit Committee shall also meet the Auditors (Statutory Auditors and Internal Auditors) separately without the presence of Management and Executive Director.
- d) Apart from the above Committees, the Board shall constitute such other Committees as may be deemed fit by it and, if required by any applicable law.
- e) The Committees may engage in any manner, from time to time such Experts as the Committees may decide for effective discharge of the Roles and

Responsibilities of such Committees.

- f) The roles and responsibilities of each Committee shall be aligned with the provisions laid down under Schedule II – Part C, D, and E of SEBI LODR, 2015.

17. FIT AND PROPER CRITERIA FOR DIRECTORS

- a) The Company shall have a policy put in place for ascertaining the 'fit and proper' criteria at the time of appointment of Directors and on a continuing basis. The NRC shall review the appointment/re-appointment of Directors considering their qualifications, expertise, track record, integrity and other 'fit and proper' criteria. The NRC should obtain such declarations/undertakings, deed of covenant from the Directors and ensure furnishing such statement and certificates as may be prescribed by the Policy for determining Fit and Proper Criteria in line with the Guidelines issued by the RBI for the time being in force.
- b) A quarterly statement on change of directors (certified by the Auditors of the Company wherever required) and a certificate by the Managing Director of the Company certifying that 'fit and proper' criteria in selection of Directors has been followed by the Company should be furnished to the Regional Office of the RBI in terms of the Guidelines issued by the RBI for the time being in force.

18. POLICIES OF THE COMPANY

- a) Presently the Company has adopted and revised from time to time the following Policies as approved by the Board and various Committees of the Company subject to provisions contained in the RBI Regulations/ Directions, the Companies Act, 2013 and other Applicable Laws -
- Risk Management Policy;
 - Corporate Social Responsibility (CSR) Policy;
 - Code of Conduct Board of Directors and Senior Management personnel;
 - Whistle Blower Policy;
 - Dividend Distribution Policy;

- Details of Familiarization Programs for Independent Directors;
- Policy for Determination of Materiality of Events or Information;
- Policy on Board Diversity;
- Code of Practices and Procedures for Fair Disclosure of Unpublished Price Sensitive Information;
- Policy for Preservation of Documents;
- Nomination and Remuneration Policy;
- Hedging Policy
- Policy on Related Party Transactions;

b) The Company shall also adopt such Policies as approved by the Board and/or its various Committees from time to time as may be required by any Direction of RBI and Applicable Laws.

19. DISCLOSURE TO THE BOARD

The following disclosures shall be made to the Board of Directors at regular intervals (preferably once in a year) as may be prescribed by the Board in this regard:

- a) progress made in putting in place a progressive risk management system, and risk management policy and strategy followed;
- b) conformity with Corporate Governance standards viz. in composition of various Committees, their role and functions, periodicity of the meetings and compliance with coverage and review functions, etc.

20. DISCLOSURE IN THE FINANCIAL STATEMENTS

- a) In addition to the disclosures required to be made as per the Applicable Laws, the following additional disclosures shall be made in the annual financial statements in terms of the RBI Directions:
 - registration/license/authorisation by whatever name called, obtained from either financial sector regulators;
 - ratings assigned by credit rating agencies and migration of ratings during the year

- penalties, if any, levied by any regulator; and
 - asset-liability profile, Non-Performing Assets (NPA) and movement of NPAs, details of all off-balance sheet exposures, structured products issued by them as also securitization/ assignment transactions and other disclosures.
- b) Requisite disclosures as may be required under any Applicable Laws from time to time shall also be made in the Financial Statements.
- c) The Company shall comply with Regulation 34 of SEBI LODR, 2015, for disclosures in the Annual Report, including:
- Management Discussion & Analysis (MD&A)
 - Corporate Governance Report
 - Business Responsibility and Sustainability Reporting (BRSR) (for top 1000 listed entities)
 - Certificate of Non-Disqualification of Directors
 - CEO & CFO Certification under Regulation 17(8)

21. APPOINTMENT AND ROTATION OF STATUTORY AUDITORS/AUDIT PARTNER(S)

- a) Subject to the provisions contained in the Companies Act, 2013, the Auditor of the Company shall be appointed with the approval of the Shareholders at the Annual General Meeting as recommended by the Board of Directors of the Company based on the recommendation of the Audit Committee of the Company.
- b) The Company in addition to the provisions of the Companies Act, 2013 shall also comply with the RBI guidelines for the appointment of Statutory Auditors, rotation of partners of the Firm conducting Statutory Audit from time to time. As contained in the Directions, presently the Company is required to rotate the partner of the Chartered Accountant firm conducting the audit, every three years so that same partner does not conduct audit of the company continuously for more than a period of three years.
- c) However, the partner so rotated will be eligible for conducting the audit of the

company after an interval of three years, subject to approval of the shareholders and recommendations of the Board and Audit Committee of the Company. The Company shall also incorporate appropriate terms in the letter of appointment of the firm of auditors and ensure its compliance.

- d) An audit firm would not be eligible for reappointment in the Company for six years (two tenures) after completion of full or part of one term of the audit tenure.
- e) Add reference to SEBI Circular dated October 18, 2021 (for listed entities) regarding eligibility, independence, and cooling-off period for statutory auditors, where applicable.

22. REVIEW OF POLICY

- a) The Board or its Committee may review the policy from time to time as may be required. Changes, if any, shall be effective only upon approval by the Board.
- b) This policy shall be reviewed periodically by the Board in line with any amendments in SEBI LODR, 2015, RBI Guidelines, and Companies Act, 2013.
